Executive summary

Eczema (also known as dermatitis) is a long-term inflammatory immune mediated disease that can affect people from infancy to old age. The most common form, atopic eczema, affects 1 in 5 children and 1 in 10 adults in the UK.¹ Around one third of people experience moderate-to-severe symptoms.²

This report features the findings of a major new survey commissioned by National Eczema Society, in collaboration with LEO Pharma, into the true impact of eczema on patients' lives. The findings show that eczema can have a profound and often hugely detrimental impact on both patients and their families. Eczema affects physical health, mental health, quality of life and even life choices. These realities often remain hidden or are left unspoken to most, but millions of children and adults with eczema are facing these consequences every day.

In the following infographic we bring together some of the key findings to highlight the impact of eczema on the lives of people living with the condition and their families.

Not just a skin complaint

over half of NHS Trusts (53%) didn't have a documented pathway for atopic dermatitis⁵ Whilst highlighting the stark reality of living with eczema, there are opportunities to improve outcomes for those with the condition.

The evidence in this report shows where change is urgently needed to improve patient outcomes. Our key calls to action are:

1

Strengthen the voices of those living with eczema

Through the report, we want to raise public awareness of what it is truly like to live with eczema and dispel the commonly held myth that eczema is just a minor skin complaint. We want to empower people to talk about their eczema, knowing that others are going through similar experiences, and to feel renewed confidence to press for the medical care and support they need. Talking is so important in breaking out of the isolation that can come from the daily grind of living with a painful long-term condition. The report also provides healthcare professionals with new evidence and a deeper understanding of patients' true experiences of eczema. This knowledge should serve as an opportunity and catalyst to improve patient outcomes through more effective holistic approaches to care.

Develop clinical guidelines and quality standards for adults and adolescents with eczema

There are no National Institute for Health and Care Excellence (NICE) clinical guidelines and quality standards to guide the diagnosis and management of adults and adolescents living with eczema. This is remarkable bearing in mind the number of people affected and the costs to the health economy. The absence of such frameworks leads to huge variations of care, both at primary and secondary/ tertiary care level, with healthcare professionals relying heavily on their own individual knowledge and clinical judgement to treat patients. Greater standardisation in clinical care driven by evidence-based treatment guidelines is urgently needed to improve patient outcomes. Such frameworks will be critical in guiding commissioning decisions and prioritising healthcare resources effectively while ensuring people living with eczema have consistent access to optimal care and treatment.

Improve access to appropriate care and services

Dermatology represents an important part of the National Health Service (NHS) provision, and yet there are fundamental barriers to accessing appropriate care and services for patients with conditions like eczema. There is an urgent need to improve knowledge of skin diseases and their wider impact on patients within primary care settings. It is also imperative that we bridge the gap between specialist and primary care services to ensure patients are referred to the right service, in the right place, at the right time and no patient is left untreated or unsupported. Ultimately, we hope this report will act as a catalyst to urge clinicians, commissioners and policymakers to ensure effective care is prioritised locally and services appropriately funded to reduce the unnecessary variation in care and knowledge that currently exists across the country.

What is eczema?

Eczema (also known as dermatitis) is a chronic inflammatory immune mediated disease. It is a highly individual condition that varies from person to person and comes in many different forms and severities. The most common form, atopic eczema, affects 1 in 5 children and up to 1 in 10 adults in the UK¹. Of those with atopic eczema, 30 % have moderate-to-severe disease, with approximately 5 % having severe disease².

We do not fully understand all the causes of eczema, although genes are often an important factor. It often starts in early infancy and can continue through into older age. In mild cases of eczema, the skin is dry, scaly, red and itchy. In more severe cases, there may be large areas of the body covered by weeping, crusting and bleeding skin, and these symptoms have a far-reaching and significant impact on daily life. For many people with eczema, the skin can be unbearably itchy, and the urge to scratch becomes irresistible, leading to what is known as the itch–scratch cycle. Constant scratching damages the skin, causing it to split and bleed and also leaves it open to infection. Common triggers for a flare-up include stress, seasonal changes in temperature and certain shampoos, soaps and cosmetics.

More than just a skin complaint: The true impact of eczema

For those who have never experienced eczema or know little about the condition, it may seem as though it is just a minor skin complaint. But eczema is not just skin deep.

National Eczema Society, in collaboration with LEO Pharma, surveyed 524 parents of children (aged 0–16) with eczema and 530 adults with eczema in the UK. The results demonstrate that eczema can have a profound and often hugely detrimental impact on patients and their families. This impact is not simply physical—it can affect mental health, day-to-day living, relationships, sleep and long-term life opportunities, among other things.

In this context, this report examines how eczema affects your physical health, your mental health, your quality of life and your life chances. And, importantly considers people's experiences of accessing effective care.

Physical health

Eczema is so much more than just red and itchy skin. People with eczema can experience a wide range of painful physical symptoms that are variable and often difficult to manage effectively with current treatments.

When asked about the physical impact of eczema, nearly all of the survey respondents reported experiencing itchy skin (96% of adults and 95% of children).³ Other physical symptoms and impacts related to eczema include:³

Cracked and/or inflamed skin

 Around two thirds of the respondents reported experiencing skin so sore that it bleeds (67% of adults and 60% of children)³

General discomfort and skin sensitivity

- Nearly two thirds (63%) of adults surveyed said eczema has negatively impacted their physical functioning³
- Nearly half (45%) of parents said the disease impacts the amount of exercise their child with eczema can do³
- Infection (often identified by fluid oozing from the skin and a yellow crust on the skin surface)
 - Three fifths (62%) of adults reported their skin weeping or oozing clear fluid in the previous four weeks³

Physical health is intrinsically linked with mental health, and yet there is a worrying lack of psychological support available to people living with skin conditions like eczema. There is an urgent clinical need to equip healthcare professionals with the necessary skills and resources to provide the holistic care that patients need. We also need an open dialogue between healthcare professionals and patients asking difficult questions to better understand how patients are feeling so we can provide necessary support and psychological interventions."

Mental health

Although eczema is relatively common, it is rarely spoken about in terms of its impact on mental health and how it can cause things like anxiety and depression.

Having to deal with an unrelenting cycle of itchy and painful skin, coupled with the wider impacts associated with eczema (for example, lack of sleep and feelings of self-consciousness over the appearance of the skin), can be wearing for patients and take an emotional toll.

of adults surveyed said eczema negatively impacts their mental health. Other survey findings include:

- Low self-esteem and feelings of embarrassment
 - 85% of adults reported feeling embarrassed as a result of their eczema, with four in five saying they feel envious of people with more typical skin³
- Anxiety, stress and depression (which can also trigger flare-ups)
 - 79% of adults reported feeling anxious as a result of their eczema, with a similar proportion saying they feel depressed or sad because of it³
- Feeling lonely/socially isolated
 - 66% of adults said they were lonely/socially isolated because of their eczema (for children in the survey the figure is 43%)³

As the survey results demonstrate, eczema can have a profound and debilitating impact on mental health. It is therefore vitally important that people living with eczema have access to appropriate information and support services to help them manage the emotional and psychological impact of their condition. However, there is still much work to be done. Over half of the adults surveyed said they had never been offered an emotional or psychological support service by a NHS doctor to help them cope with the mental health impact of their eczema. ³

These data support a **recent report** (published September 2020) from the All Party Parliamentary Group on Skin, which also revealed a worrying lack of mental health support for skin disease patients, urging commissioners to urgently invest funding to improve mental health services that are dedicated to dermatology patients.⁴

I have lived with severe eczema for decades and, over what is perhaps now hundreds of consultations, have rarely been asked 'How are you feeling?'

In my experience the health impact of eczema is not well understood or addressed."

Quality of life

It is not always obvious how much eczema impacts on a person's life. The survey findings show that eczema affects people's quality of life in many ways, particularly the ability to sleep, and impacts on social life, sexual intimacy, friendships and a range of day-to-day activities. Nine in 10 (89%) adults and three quarters (76%) of parents of a child with eczema say eczema significantly reduces their or their child's quality of life.³

Impact on sleep

• 61% of adult patients say they have had trouble falling or staying asleep at least once a week as a result of their eczema, and for children in the survey it was 57% ³

• Impact on relationships and intimacy

- One in five (18%) adult respondents say they have struggled to find someone attracted to them because of their eczema, and 1 in 10 (11%) say their relationships have ended because of their eczema³
- Three fifths of the adults surveyed said eczema has negatively affected their sexual intimacy (59%)³
- Survey responses show one third (33%) of children with eczema have tried to keep their eczema hidden from their friends³

• Impact on social life

- Half of parents say the disease has negatively impacted their child's social life (48%), two fifths (41%) say the same about their child's ability to make new friends and nearly two fifths (37%) say the same about their child's existing friendships³
- Three fifths of the adults surveyed said eczema has negatively affected their social life (61%) ³

Impact on day-to-day life

 Doing everyday tasks, like getting dressed and washing, can be extremely painful when the skin is cracked, red and raw. More than half of the survey respondents reported that their eczema has interfered with their ability to do regular daily activities³

Despite the significant negative impact of eczema on patients' quality of life, one third of respondents reported feeling that they are not being taken seriously by their healthcare professional, and two fifths (39%) feel let down by them.³ This highlights the challenge for both patients and healthcare professionals in managing a complex, variable condition like eczema and lack of effective treatments, leaving people disillusioned.

Opportunities and decisions about the future

Eczema can have a significant, and sometimes life-changing, impact on people's decisions and opportunities, particularly among those living with more severe eczema. These range from decisions over whether to have children through to more limited education and work choices.



Work life and career progression

- Nearly half of adult respondents said eczema had affected their ability to do paid work, which can have a significant impact on personal and financial welfare ³
- Others report having lost a job (9%), some think they had been overlooked for promotion (13%), and some said they had lost wages, specifically because of their eczema ³




Education

- Of the parents surveyed, more than half said their child had to take time off school
 due to their eczema, and one in seven parents said their child has taken more than
 10 days off during the last year. This raises concerns about the impact on the future
 education and prospects for children living with poorly controlled eczema ³
- One fifth of parents in the survey said their child has to limit certain activities at school, and their child regularly mentions having difficulty concentrating in class because of their eczema³



Starting a family

 14% of adults surveyed said their eczema has influenced their thoughts and decisions about whether to have children; this more than doubled for those with severe eczema³

Accessing effective care

While there is no cure for eczema, there are medical treatments and other support services available to support patients in managing their symptoms and condition.

The survey shows a mixed picture of peoples' experiences in accessing the healthcare support they need, with one third saying they felt let down by their healthcare professionals about treatment for their eczema. It is important to recognise good care practice, with some people reporting that they are receiving the support and treatment needed. However, the survey highlighted considerable variation in healthcare provision and some key gaps.³

Issues identified with the provision of care include:



Written eczema care plans

 Around half of the parents report their children do not have a written care plan for their eczema, and this includes children with moderate and severe eczema. There is a similar pattern among adult patients, with three fifths reporting they have no such plan in place ³



Patients' perceptions regarding their healthcare professional

 One quarter of respondents do not think that they are being taken seriously by healthcare professionals, who do not fully understand the impact of eczema on individuals' lives. This shows there is a need to bridge the gaps in between healthcare professionals and people living with eczema ³



Referrals to secondary care

- There are concerns about waiting times for GP referral to secondary care ³
- 35% of adults say on the last occasion they were referred to a dermatologist, they had to wait more than 3 months for an appointment (42% for adults with moderate, severe or very severe eczema), with 14% of adults waiting more than 6 months and 5% of adults waiting more than a year.³
- Similarly, 32% of parents said their child had to wait more than 3 months for their last appointment with a dermatologist or paediatrician ³



Support networks

- Positively, most adults do appear to have support networks to help them cope
 with their eczema. Approaching three quarters (72%) say close friends and
 family understand how difficult and painful eczema can be, and three in five
 (61%) say some of their close family and friends have eczema, which helps
 with mutual understanding and support 3
- Additional support for children is needed: Nearly three quarters (71%) of parents say they have seen their child visibly upset or crying because of their eczema; and 23% of parents said their child has been bullied or teased in person because of their eczema³



Access to treatments

- Access to treatments was cited as a concern by many respondents who said that they or their child regularly has difficulty obtaining the treatment they require to manage their eczema³
- Nearly one third of adults surveyed say they often have difficulty obtaining the emollients they need on NHS prescription³
- 16% of adults say they have had difficulty obtaining phototherapy treatment ³
- Over a quarter of adult respondents with moderate, severe or very severe eczema have had challenges obtaining a biologic treatment to manage their eczema³

Many factors influence appropriate access to treatments for eligible patients, such as whether dermatology units have the dedicated personnel or services in place for the prescription and administration of specialist treatments, or if they have a local documented treatment pathway in place. These are all aspects which have been shown to vary significantly across the country.⁵

While national guidelines for eczema management do exist for children, these findings highlight the urgent need for National Institute for Health and Care Excellence (NICE) clinical guidelines and quality standards for the management of adults and adolescents with eczema to ensure consistently high quality of care and optimal patient outcomes. It is also important that dermatology services evolve to meet current and future patient needs, ensuring quality of care at both primary care and specialist service-level is not compromised and access is equitable.

Due to a lack of undergraduate and postgraduate training, often coupled with inadequate local resources to draw on, sadly many GPs are not always equipped to cope with the full needs of people living with a complex condition like eczema, as highlighted by this new data.

There is a critical need to address these education and service gaps as we know that up to a quarter of all GP consultations include an element of dermatology yet, astonishingly, this is still not considered a priority."

The Future: Expectations and opportunities for managing eczema

Above all, we want the 'Eczema Unmasked' report to better represent the experiences of children and adults with eczema and importantly serve as a new, robust evidence base to demonstrate how eczema can significantly impact people's physical health, mental health, their quality of life, long-term life opportunities and access to appropriate care.



Methodology

The National Eczema Society, in collaboration with LEO Pharma, surveyed 524 parents of children (aged 0–16) with eczema and 530 adults with eczema in the UK. Surveys were conducted online between 12 June and 11 July 2020. Participants were screened using a proxy for Eczema Area and Severity Index (EASI) scores to gather a range of participants from almost clear, mild, moderate, severe and very severe eczema. The EASI scoring system uses a tested calculation to grade the severity of eczema symptoms and the extent different areas of the body have been affected.

With a sample size of 524 parents of children with eczema, the margin of error on results at a 95% confidence level is ± 4.28 . Differences of less than this should be treated as indicative and insignificant.

With a sample size of 530 adults with eczema, the margin of error on results at a 95% confidence level is ± 4.26 . Differences of less than this should be treated as indicative and insignificant.
